- to carry out post-crisis analysis in conjunction with relevant institutions and make recommendations to the Government and other relevant institutions with regard to risk prevention, better preparedness and improved crisis management.

The Crisis Response Team shall—

- receive and collect information on any actual or potential risk;
- evaluate and assess the available information with regard to the significance and magnitude of the actual and potential risk;
- manage the communication and dissemination of information to all institutions in timely manner; and
- assist with co-ordination, monitoring and re-evaluation of the risk response efforts.

The Committee shall work closely with the National Disaster Management-Co-ordination Centre and other relevant institutions in the management of all crisis situations.

In the performance of its function, the Committee may co-opt such additional expertise as may be required from time to time, on specialized aspects of its terms of reference.
