Standards Levy, Mobile Cellular Phone Excise Duty,
Sugar Development Levy & Excise Duty**

Due Date: Monday 20th April, 2009

Kenya Revenue Authority would like to remind all Taxpayers (Companies and Individuals) that the Due Date for the above-mentioned Taxes will be Monday 20th April, 2009 as detailed below:-

1. Withholding Tax Deductions made during the month of March, 2009.
2. Instalment Tax from Taxpayers whose Accounting Periods end on:
 - i) 31st December - 1st Instalment and balance of tax if any.
 - ii) 31st October - 2nd Instalment
 - iii) 31st July - 3rd Instalment
 - iv) 30th April - 4th Instalment
3. VAT [Monthly Returns (VAT 3)], Standards Levy and Sugar Development Levy Returns for the month of March, 2009
4. Excise Duty for the month of MARCH, 2009
5. Turnover Tax for the 1st quarter ending 31st March 2009.
