Bidders to note that bidding for more than one lot will lead to Automatic disqualification. We feel this restriction is closing us out on the opportunity of giving a variety of financial offers/proposals within our qualifications.	 1. Bidders to note that ITT 1.1 has been amended to read, bidders are allowed to bid for more than one (1) LOT. Bidders who participate in more than one lot should note that they will only be awarded one lot. (No Bidder will be awarded more than one LOT) NOTE: The procuring Entity will consider all possible combination of won lots and determine the best lowest financial combination i.e the most advantageous combination to the Authority.
	We respectfully request that you reconsider this criterion and allow bidders to quote for various lots but be awarded one lot where they emerge the lowest evaluated bidders to enable the institutions to also save on cost amounts on financial proposals.	2. Bidders are advised that ITT 35.4 has been amended to read: Tenderers shall be allowed to quote separate prices for different LOTS and the methodology to determine the lowest tenderer is specified in ITT 1.1
