1	LOT 1 MANDATORY REQUIREMENT	We have noted that the turnover requirement in the tender document for TENDER NO. KRA/HQS/NCB-002/2024-2025 has been set at a minimum of KES 900 million. We believe this threshold may be discriminatory and potentially tailored to favour a particular bidder. While we acknowledge that turnovers are important in assessing a company's creditworthiness, they should be considered alongside other financial and qualitative metrics such as profitability, cash flow, liquidity, debt levels, and prevailing market conditions.	The Authority is seeking bidders with robust financial capacity based on the nature of the contract. They should be able to absorb the payment shocks caused by overdue payments of not less than 90 days. Prospective bidders are therefore advised that this criterion remains unchanged
2	LOT 1 VENDOR REQUIREMENTS		Prospective bidders are advised that the vendor requirements for Lot 1 in pages 34 to 35 of the tender document have been expunged and replaced with LOT 1: VENDOR EVALUATION-AMENDED
