

STEP BY STEP GUIDE ON HOW TO APPLY FOR WITHHOLDING VAT EXEMPTION

The Finance Act 2023 introduced Exemption from Withholding VAT of registered manufacturers whose value of investment in the preceding three years from 1st July,2022 is at least three billion. The effective date of this change is 1st July 2023.

The application process is available on the iTax portal. Upon approval at the respective Tax Service Office, the system will generate a withholding VAT exemption certificate which will be communicated to your iTax registered email address.

STEPS:

- 1. Log into your iTax profile via the url *itax.kra.go.ke*
- 2. Select Registration >> Other Registration >> VAT WHT Exemption



3. The system will display the application form as shown below:
