1.2 Registration Objectives

The main objective of this part is to short-list firms for supply and delivery of assorted goods and services under relevant Quotations as and when required in compliance with sections 57 and 71 of the Public Procurement and Asset Disposal Act, 2015.

1.3 Invitation for Registration

Firms registered with Registrar of Companies under the Law of Kenya are invited to submit their registration documents to **The Deputy Commissioner – Supply Chain Management** so that they may be registered for submission of Quotations. The Authority requires prospective suppliers to provide mandatory information for registration.

1.4 Experience

Past Experience in the supply and delivery of similar goods/services is mandatory for all OPEN categories. (Documentary evidence in the form of ONE LPO/LSO with a corresponding Recommendation Letter/Certificate of Completion to be submitted). This requirement is exempt for AGPO groups.

1.5 Registration Document

This document includes a confidential business questionnaire form and documents required from prospective suppliers. In order to be considered for registration, prospective suppliers/providers **MUST** submit all the information herein requested.

1.6 Distribution of Registration Documents

Registration documents shall be downloaded from the Authority's website www.kra.go.ke and the Public Procurement Information Portal (PPIP). The documents are available for inspection from the Supply Chain Department, Kenya Revenue Authority – KRA Times Tower Building, 21st Floor, Nairobi, during normal working hours, and submitted on or before 23RD APRIL 2025 AT 11.00 A.M.
